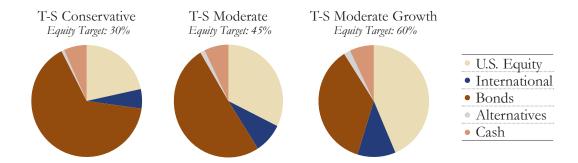


MADISON MOSAIC - TAX-SENSITIVE PORTFOLIO ALLOCATIONS March 31, 2024
